Cluster manager selection

As lead schools work through the process of appointing cluster managers, it is timely to clarify lead schools' obligations around this. While schools may seek to appoint a permanent cluster manager immediately, this is not a requirement. A number of schools are employing cluster managers on fixed term contracts to ensure reasonable opportunity for the best candidate for the job to be appointed. As the cluster manager role is a key one, the Ministry supports this.

Laptop leases

We have been receiving a number of queries recently related to laptop leases. Please note the following points when liaising with your laptop supplier. This information may also be generalised to other administrative expenses of a similar nature.

At the moment, current employing schools are receiving cluster funding and should continue to pay the laptop lease until the start of 2012. In most cases, unless laptop leases are up for renewal, rather than terminate the lease early we advise lead schools to establish reimbursement arrangements with current employing schools from the start of next year. This is to avoid the 2011 employing school incurring unnecessary penalty payments.

We understand that some leases may not be transferable between schools. Schools should confirm this with their suppliers.

Suppliers should note that an employee does not 'own' the laptop lease; the employing school does and RTLB will not be able to take the laptop with them if they do leave the service.

It is understandable that some 2011 employing schools may not wish to continue with the laptop lease past the end of this school year. It is only a recommendation that the 2011 employing school continue with the laptop lease and the new lead school reimburse them for any costs including repairs and similar. Schools should work together to consider what the best option is for their circumstances.
